  - o Funds increased 7.71%, or 1.82x the market
  - o Market share increased from 13.87% to 16.50%
    - ➤ An increase of 18.91%
- Prime Brokers ranked >25 registered the smallest growth in funds
  - o Funds decreased 59.52%, or -5.32x the market
  - o Market share decreased from 18.29% to 8.18%
    - ➤ A decrease of 55.31%
