Best and Worst Performing Peer Groups

- Auditors ranked 11-25 registered the highest growth in funds
 - Funds increased 13.86%, or 4.45x the market
 - Market share increased from 4.21% to 4.65%
 - An increase of 10.42%

- Auditors ranked >25 registered the smallest growth in funds
 - Funds increased 2.57%, or 0.82x the market
 - Market share decreased from 3.59% to 3.57%
 - A decrease of 0.53%

Best and Worst Performing Peer Groups

- Auditors ranked 1-4 registered the highest AuA growth
 - AuA increased 17.09%, or 1.18x the market
 - Market share increased from 66.86% to 68.41%
 - An increase of 2.32%
- Auditors ranked >25 registered the lowest AuA growth
 - AuA decreased 20.14%, or -1.40x the market
 - Market share decreased from 0.76% to 0.53%
 - A decrease of 30.21%
