 - Funds increased 11.07%, or 2.56x the market
 - Market share increased from 6.98% to 7.43%
 - An increase of 6.47%
- Admins ranked 1-5 registered the smallest growth in funds
 - Funds decreased 1.06%, or - 0.25x the market
 - Market share decreased from 15.20% to 14.42%
 - A decrease of 5.16%

 - Market share increased from 26.53% to 27.45%
 - An increase of 3.47%
- Admins ranked >25 registered the lowest AuA growth
 - AuA increased 8.79%, or 0.94x the market
 - Market share decreased from 10.94% to 10.89%
 - A decrease of 0.48%
