  - o Market share increased from 7.86% to 8.27%
    - ➤ An increase of 5.32%
- Prime Brokers ranked 1-10 registered the smallest growth in funds
  - o Funds increased 1.68%, or 0.67x the market
  - Market Share decreased from 75.55% to 74.92%
    - ➤ A decrease of 0.83%
