Best and Worst Performing Peer Groups

- Auditors ranked 11-25 registered the highest growth in funds
 - Funds increased 23.95%, or 5.34x the market
 - Market share increased from 4.53% to 5.38%
 - An increase of 18.63%
- Auditors ranked >25 registered the smallest growth in funds
 - Funds decreased 11.31%, or -2.52x the market
 - Market share decreased from 4.04% to 3.43%
 - A decrease of 15.12%

- Auditors ranked 11-25 registered the highest AuA growth
 - AuA increased 36.71%, or 3.28x the market
 - Market share increased from 0.92% to 1.13%
 - An increase of 22.96%
- Auditors ranked >25 registered the lowest AuA growth
 - AuA decreased 22.27%, or -1.99x the market
 - Market share decreased from 0.72% to 0.50%
 - A decrease of 30.09%
