Best and Worst Performing Peer Groups

- Auditors ranked 11-25 registered the highest growth in funds
 - Funds increased 22.92%, or 4.73x the market
 - Market share increased from 4.67% to 5.47%
 - An increase of 17.24%
- Auditors ranked >25 registered the smallest growth in funds
 - Funds decreased 13.59%, or -2.81x the market
 - Market share decreased from 4.02% to 3.32%
 - A decrease of 17.58%

Best and Worst Performing Peer Groups

- Auditors ranked 11-25 registered the highest AuA growth
 - AuA increased 23.80%, or 1.96x the market
 - Market share increased from 1.03% to 1.14%
 - An increase of 10.37%
- Auditors ranked >25 registered the lowest AuA growth
 - AuA decreased 10.02%, or -0.82x the market
 - Market share decreased from 0.58% to 0.47%
 - A decrease of 19.78%
