Best and Worst Performing Peer Groups

- Auditors ranked 11-25 registered the highest growth in funds
 - Funds increased 7.91%, or 2.52x the market
 - Market share increased from 3.24% to 3.39%
 - An increase of 4.63%
- Auditors ranked >25 registered the smallest growth in funds
 - Funds decreased 19.72%, or -6.29x the market
 - Market share decreased from 2.85% to 2.22%
 - A decrease of 22.16%

 - AuA increased 15.50%, or 1.04x the market
 - Market share increased from 2.83% to 2.85%
 - An increase of 0.50%
- Auditors ranked >25 registered the lowest AuA growth
 - AuA decreased 20.19%, or -1.35x the market
 - Market share decreased from 0.50% to 0.35%
 - A decrease of 30.55%
