Best and Worst Performing Peer Groups

- Auditors ranked 5-10 registered the highest growth in funds
 - Funds increased 9.34%, or 2.62x the market
 - Market share increased from 4.46% to 4.71%
 - An increase of 5.57%
- Auditors ranked >25 registered the smallest growth in funds
 - Funds decreased 19.20%, or -5.39x the market
 - Market share decreased from 2.87% to 2.24%
 - A decrease of 21.98%

- Auditors ranked 5-10 registered the highest AuA growth
 - AuA increased 16.51%, or 1.08x the market
 - Market share increased from 2.84% to 2.87%
 - An increase of 1.12%
- Auditors ranked >25 registered the lowest AuA growth
 - AuA decreased 19.25%, or -1.26x the market
 - Market share decreased from 0.50% to 0.35%
 - A decrease of 29.92%
