Best and Worst Performing Peer Groups

- Admins ranked 6-10 registered the highest growth in funds
 - Funds increased 12.69%, or 2.88x the market
 - Market share increased from 5.55% to 5.99%
 - An increase of 7.94%
- Admins ranked >25 registered the smallest growth in funds
 - Funds increased 0.85%, or 0.19x the market
 - Market share decreased from 21.09% to 20.37%
 - A decrease of 3.40%

- Admins ranked 1-5 registered the highest AuA growth
 - AuA increased 23.86%, or 1.36x the market
 - Market share increased from 23.15% to 24.40%
 - An increase of 5.37%
- Admins ranked >25 registered the lowest AuA growth
 - AuA increased 13.07%, or 0.74x the market
 - Market share decreased from 11.79% to 11.34%
 - A decrease of 3.81%
