Best and Worst Performing Peer Groups

- Admins ranked 6-10 registered the highest growth in funds
 - Funds increased 14.50%, or 2.07x the market
 - Market share increased from 5.83% to 6.23%
 - An increase of 7.02%
- Admins ranked 11-25 registered the smallest growth in funds
 - Funds increased 3.68%, or 0.53x the market
 - Market share decreased from 12.15% to 11.77%
 - A decrease of 3.10%

- Admins ranked 1-5 registered the highest AuA growth
 - AuA increased 28.65%, or 1.35x the market
 - Market share increased from 23.68% to 25.12%
 - An increase of 6.08%
- Admins ranked >25 registered the lowest AuA growth
 - AuA increased 17.33%, or 0.81x the market
 - Market share decreased from 16.26% to 15.73%
 - A decrease of 3.26%
