Best and Worst Performing Peer Groups

- Auditors ranked 11-25 registered the highest growth in funds
 - Funds increased 12.24%, or 2.13x the market
 - Market share increased from 3.43% to 3.64%
 - An increase of 6.15%
- Auditors ranked 1-4 registered the smallest growth in funds
 - Funds increased 3.33%, or 0.58x the market
 - Market share decreased from 25.65% to 25.07%
 - A decrease of 2.28%

 - AuA increased 26.83%, or 1.35x the market
 - Market share increased from 2.83% to 3.00%
 - An increase of 5.84%
- Auditors ranked >25 registered the lowest AuA growth
 - AuA increased 2.67%, or 0.13x the market
 - Market share decreased from 0.40% to 0.34%
 - A decrease of 14.32%
